Noxious Weed Ordinance Enforcement

Dear Property Owner:

This will be the only notification that you will receive for this season's 2018 Noxious Weed Enforcement.

A copy of this letter is posted on our web site www.WashingtonTownship.org. This letter includes the dates for maintenance and inspections.

*As a property owner you are responsible to maintain your property **year round**. The weeds and grass cannot exceed a height of eight (8") inches. This may be achieved by any acceptable means, but you may not destroy the weeds by fire. The property also needs to be kept free from debris.*

**Per Local Ordinances (Ord. 41 part 101.000 and Ord. 94 part 103.000),
the property owner is responsible to maintain their property at all times
which includes weeds/overgrowth and debris/blight.**

The Township recommends that you make a note of the following dates:

First (1 st) owner's cut	May 23 – May 30, 2018
Township Inspections	May 31 – June 6, 2018
Township maintenance	June 7 – June 15, 2018
Second (2 nd) owner's cut	June 28 – July 5, 2018
Township Inspections	July 6 – 12, 2018
Township maintenance	July 13 – 20, 2018
Third (3 rd) owner's cut	August 12 – 18, 2018
Township Inspections	August 20 – 24, 2018
Township maintenance	August 27 – 31, 2018
Fourth (4 th) owner's cut	September 24 – 30, 2018
Township Inspections	October 1 – 5, 2018
Township maintenance	October 8 – 12, 2018

This letter contains the
recommended dates of maintenance.

However your property needs to be in
compliance with the
Township's Noxious Weed Ordinance
at all times.

If your property is found in violation at **any** time during the weed growing season, the Township's Department of Public Works will then make their own inspection, and if necessary maintain/bring your property into compliance at a cost of **\$250.00** per lot/per incident.
