The above-named Applicant hereby makes Application for a "License for Excavating Contractor" for the year indicated above commencing on April 1st and ending on March 31st of the following year. Said Applicant agrees that, if he is granted this License, he will abide by the following conditions:

1. The contractor will hold harmless and indemnify the Township for all liability arising out of the performance of his work.
2. The contractor will give notice to the Township Sewer and Water Department at least two (2) normal working days prior to his intended commencement date for any new project in the Township for which he is engaged.
3. The Contractor will ascertain and comply with all Ordinances that regulate the work for which he is engaged.
4. If the Contractor damages the existing Wastewater Facility or causes foreign material to enter this system, he shall be responsible for making the necessary repairs or cleaning the system as directed by the Superintendent of the Sewer and Water Department. Failure to comply with these requirements within forty-eight (48) hours shall cause the Township to take whatever remedial action is necessary to resolve the situation and said cost shall be paid by the Applicant or his Security Company.
