VIII. NOTICE TO APPLICANT

GENERAL: Electrical work shall not be undertaken until an electrical permit is issued. All installations shall be in conformance with the Electrical Code. No work shall be concealed until it has been inspected and approved.

EXPIRATION OF PERMIT: A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated.

LOCK BOX: If using a lock box, the number must be provided each time ANY inspection is requested. Lock box numbers will not be stored in our systems. If inspector is locked out, re-inspection fee will be charged. **NO EXCEPTIONS.**
