VIII. NOTICE TO APPLICANT

GENERAL: Plumbing work shall not be undertaken until a plumbing permit is issued. All installations shall be in conformance with the Plumbing Code. No work shall be concealed until it has been inspected and approved.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. Canceled permits cannot be refunded or reinstated.

LOCK BOX: If using a lock box, the number must be provided each time **ANY** inspection is requested. Lock box numbers will not be stored in our

- Work completed by a governmental subdivision or state agency costing less than \$15,000.

Such plans shall be prepared or under the direct supervision of an architect or engineer licensed pursuant to Act NO. 299 of the Public Acts of 1980, as amended, and shall bear that architect's or engineer's signature and seal.
