**6. SUPPORTING DATA REQUIRED WITH THIS APPLICATION: (as required in Ordinance 83)**

- A. Three copies of the approved and recorded finish grade plan and approved reclamation plan along with proof that these plans have been recorded with the Macomb County Register of Deeds, and that they are covenants running with the land, binding the property until reclamation is complete.
- B. Progress report on the excavation and reclamation: Three (3) accurate, current copies of proposed operating plan showing areas disturbed, areas reclaimed and proposed areas of operation during the calendar year covered by the application. An estimate of the volume of soil to be removed from the site and an estimate of any fill to be brought on site, its volume and description.
- C. Permit fee and escrow deposit -You are required to provide both a cash escrow account and a financial guarantee in forms and amounts acceptable to the Township. After completion of the field inspection for the current renewal period and prior to issuance of the license renewal, you may be required to increase the amounts to match current site conditions. At the time of application you must submit the minimum following amounts: non-refundable permit fee \$1,000, \$3,000 escrow, and a Financial Guarantee in the amount and approved method as specified in Section 27.06 of the ordinance based on acreage. Three (3) copies of each will be required.
- D. Three (3) current copies of the public liability and property damage insurance policies covering the operation.
- E. All permits required—NPDES, Soil erosion, etc.—three (3) copies of each.

**7. NOTICE TO THE LICENSEE**

- A. If approved by the Washington Township Board, this license shall be valid for the calendar year for which it is approved, unless extended by the Township Board. On December 31 of the year in which the license was approved, all on-site activities shall cease until a new license has been granted by the Township Board. Submission of this renewal application with all required supporting documentation by October 1 will minimize or eliminate the period of inactivity on your site.
- B. You are required to control dust, mud, and nuisances resulting from your operation. By your signature on this application you are certifying:
  - 1) You have the legal right to authorize Township personnel and their subcontractors to enter the site to abate nuisances or ordinance violations, should you fail to do so in a timely manner.
  - 2) That you grant the Township and their subcontractors the right to enter the site to view the site, to abate nuisances or ordinance violations, should you fail to do so in a timely manner and to use cash escrow or surety funds provided by you for immediate correction of said nuisances or violations caused by your operation, both on site and on public roads utilized on your haul route to and from your site.
  - 3) That the applicant has never defaulted on any bond posted to insure performance by the applicant in connection with any gravel or mineral soil removal or any related soil removal and/or construction activity. (if applicant has defaulted on any such bond, provide a brief description of the circumstances surrounding the default, including the name of the surety, date of the default and any remedial action which was taken.)
